Seniors - born before 30.11.19434 - 20%Discount

on the whole price list (rounding up to nearest euro)

Accompanied Children Free

 for passes from 3 to 14 days (Children born after the 30.11.2001) proof of identity obligatory (Passport, Health Card, etc) Children accompanied by an adult family member will receive a free skipass from 3 to 14 days of the same type as the paying accompanying adult. (Ratio 1:1 = 1 adult and 1 child). No free skipass will be issued without proof of identity nor after the issue of the adult's skipass.


Unaccompanied Children

50% discount for skipasses from 3 to 14 days


Children 50% discount for skipasses for 1-2 days and per hour.

Discounts and Promotions

Group Discount

 1 Skipass free with every 20 skipasses issued at list price. A list of participating skiers on the organiser's headed paper is required. Excluding the period 27/12/2009 - 09/01/2010. Valid for skipasses from 1 to 14 days. Children with free passes will not be counted as part of the group. No spontaneous, improvised or otherwise non-organised groups will be recognised.


Ladies' Day

 Saturday 12th December 2009. Every female skier or snowboarder is eligible for a FREE "SUPERSKIRAMA DOLOMITI" day pass.


Ski Start

 9th-13th December 2009 Included in the price of participating hotels and apartments is a 4 day SUPERSKIRAMA DOLOMITI Adamello Brenta skipass.


Free Ski

12-20 December 2009 / 20-28 March 2010
 Included in the price of participating hotels and apartments is a 6 day SUPERSKIRAMA DOLOMITI Adamello Brenta skipass.

CONDITIONS OF SALE

- The ski pass is a personal document; under no circumstances may it be exchanged, refunded, substituted or changed in terms of its validity or duration. For ski passes from 3 - 14 days a photograph is compulsory.
- The customer should check that the given ski pass corresponds to their specific requests at the time of collection. It will not subsequently be possible to change used tickets.
- To obtain a discount for senior citizens, young persons and children, a valid identity document must be shown upon purchase (Passport, Identity Card, etc). Applications unsupported by documents will not be accepted.
- Young persons born after 30.11.1993; senior citizens born before 30.11.1944 qualify for a discount of circa 20% on 1 - 14 day ski passes (with document).
- A child, born after 30.11.2001, accompanied by an adult member of the family at the moment of purchasing a ski pass will be issued with a free pass valid for 3 - 14 days of the same type as that purchased by the accompanying adult (ratio 1 adult: 1 child) excluding free-ski weeks and the Christmas period (20 December - 5 January 2008). No free pass will be issued without a document of identification, nor will a child's pass be granted after the adult one has already been issued.
- Lost, stolen or already collected ski passes will be neither substituted nor refunded.
- No refund or exchange will be granted in the event of bad weather, closure of the ski lifts (including partial closure due to adverse weather conditions - e.g. strong wind), closure of ski slopes (due to lack of snow, races, training) or illness.
- Any abuse in the use of the ski pass, especially expired or transferred passes, will result in its immediate confiscation and cancellation; we reserve the right to take out legal proceedings against offenders under civil or criminal law.
- In the case of serious and repeated violations of the general skiing rules the ski pass may be suspended.
- The refund of a multi-day ski pass (4 days or more), which has not been used following an injury sustained on the ski pistes, will be given only to those covered by an ITASNOW policy. The refund will be issued on condition that the skier is attended to by a member of the "Soccorso-Piste" - piste first aid service - and upon presentation of a medical note issued by a medical professional directly to the insurance company. No other kind of refund or credit note will be directly issued by Funivie Folgarida Marilleva.
- Skiers who can demonstrate over 50% invalidity (documented) may obtain a 50% discount valid exclusively at Folgarida and Marilleva ski lifts on single day and multi-day ski passes and a 25% discount will be given on the same ski pass to those officially able to demonstrate invalidity of 25% to 49%.
- "Group Discount" means that the group head should present a list of names to the ticket office written on the organisation's headed note paper with photographs where necessary. The group head must pay for all the group's ski passes in one payment. The list must also indicate the kind of ticket applied for, the dates of birth of children, young people and senior citizens, with the relevant identity documents enclosed. Applications written on hotel headed paper or blank paper will not be accepted.
- Ticket offices accept cash payments and all major credit cards. Furthermore, the Management accepts bank transfers without bank charges to the payee. The bank transfer and confirmation of its arrival at the administrative offices must be made before ski passes will be issued. Bankers Drafts are not accepted.
- It is not possible to extend the validity of ski passes already issued and used.
- In the case of "packages" (Christmas and Easter) it is not possible to change the type of weekly pass even by paying extra before issue.
- The ski pass is issued exclusively on a Key Card, which requires payment of a deposit of 5.00 Euro. The deposit will be refunded upon handing back the card (which must be undamaged and working) to the ticket offices or automatic machines.
- In the case of loss of a season ticket, it must be immediately reported to Funivie Folgarida Marilleva Spa and to the local Carabinieri station. The ticket can then be dis-activated and blocked. The cost of dis-activation, blocking and issue of a new ticket is 30.00 euro.
- All ski passes, including single runs, cease to be valid at the end of the winter season and in any case expire after 30.04.2010.
- All valid Key Cards allow access to ski lifts for night skiing (at the Ottava chair lift in Folgarida and Biancaneve ski lift in Marilleva) when operating.
- Those weeks which fall between High and Low season will be considered High season if half or more of the number of days falling in a given week is High season.
- Should an invoice be required it must be requested before issuing ski passes. A receipt of payment may be issued upon request. The prices listed are inclusive of 10% Iva (Value added tax).

For everyone's safety all skiers are kindly asked to observe and respect the signs on the ski lifts, cable cars and ski slopes, to abide by the general skiing rules paying particular attention to the rules set out in Art 30 ter "Comportamento dello sciatore" - Behaviour of the skier - of the regulations for the execution of L.P. 21 April 1987 n. 7 e s.m., which is on display in all ticket offices and at the start of all the main ski lifts.
